Payment terms	<ul style="list-style-type: none"> • Upon completion of the auction, Buyer will have to pay the trade value amount to above mentioned APSCSCL account for the awarded stock, as per above mentioned timelines. Defaults	<ul style="list-style-type: none"> • In case the successful bidder fails to make the payment for awarded stock or fails to lift the stock within stipulated time then the EMD of the Buyer will be forfeited. • However, non-payment of trade proceeds by successful bidder due to certain unavoidable circumstances within delivery period, an extension of 5 bank working days shall be granted on specific request to APSCSCL in writing from the buyer and with additional charge of 5% on the trade value shall be charged by APSCSCL. In case of non – receipt of payment even after expiry of extended period of 5 bank working days beyond the original delivery period, APSCSCL and agribazaar reserves the right to treat the transaction as cancelled.
Force Majeure	<ul style="list-style-type: none"> • Should any of the force majeure circumstances, namely, act of God, natural calamity, fire, change in law or government policy, (excluding any stock limits), strikes or lockouts by workmen, war, military operations of any nature or blockades, prevent the Seller or the Buyer from wholly or partially carrying out their contractual obligations under this Contract Note, the period stipulated for the performance of this Contract Note shall be extended for as long as these circumstances prevail, provided that, in the event of these circumstances continuing for more than 15 Working Days, this Contract Note shall stand annulled

	and no penalty will be levied on either the Buyer or the Seller for non-performance of their obligations under this Contract Note.
Arbitration	<ul style="list-style-type: none"> • If any dispute, controversy or claim arises out of or in connection with this Contract Note, including any question regarding its existence, validity or termination arising out of or in connection with this Contract Note (a “Dispute”), the Parties shall use all reasonable endeavours to resolve the matter amicably. If one (1) Party gives another Party notice that a Dispute has arisen, and the Parties are unable to resolve the Dispute within fifteen (15) Working Days of service of the notice then the Dispute shall be referred to the senior executive officers of each of the Parties who shall attempt to resolve the Dispute. No Party shall resort to arbitration against the other Party under this Contract Note until fifteen (15) Working Days after such referral to a senior executive officer. • All Disputes, which are unresolved pursuant to the preceding clause and which a Party wishes to have resolved, shall be referred upon the application of any Party to and finally settled in accordance with the rules of Arbitration and Conciliation Act 1996 (as amended up to date) or any statutory amendments/modifications thereof for the time being in force at the date of this contract note (“Rules”). • The proceedings of the arbitration shall be in Vijayawada. The language of this arbitration shall be English. The courts in Vijayawada shall have exclusive jurisdiction. • The arbitrators shall have the power to grant any legal or equitable remedy or relief available under Law, including injunctive relief (whether interim and/or final) and specific performance and any measures ordered by the arbitrators may be specifically enforced by any court of competent jurisdiction. • During the course of any arbitration under this clause except for the matters under dispute, the Parties shall continue to exercise their remaining respective rights and fulfil their remaining respective obligations under this Contract Note.
General Terms and Conditions	<u>Eligibility:</u> Bidders must be a legal entity having all the required licenses and regulatory approvals required to participate in the Auction
